SRO /2 /- In exercise of the powers conferred by section 59 and 60 of the Prisons Act, 1977 (1920 A.D.), section 51 of the Prisoners Act, 1977 (1920 A.D.) and all others powers enabling it in this behalf, the Government hereby make the following amendments in the Manual for the Superintendence and Management of Jails in the State of Jammu and Kashmir, namely:-

- In Chapter XIX the existing para 19.8 shall be renumbered as 19.8.1 and the thereafter the following para shall be inserted:-
 - "19.8.2 A Child with its mother is not a prisoner and is entitled to food, shelter, medical care, clothing, education and recreational facilities as a matter of right."
- II. After Para 19.8.2 the following para shall be inserted:-
 - "19.9.1 Before sending a woman who is pregnant to jail, it shall be ensured that the jail in question has the maximum basic facilities for child delivery as well as for providing prenatal and postnatal care for both mother and child. The facilities of District Government Hospital must be availed."
- III. The existing para 19.9 shall be renumbered as para 19.9.2.
- IV. Para 19.10 shall be substituted by the following:-
 - "19.10.1 As far as possible remedies shall be made available to pregnant female prisoner to have her delivery outside the prison and where birth takes place in prison, only the name of the locality shall be recorded with the birth registration office.
 - 19.10.2 A female prisoner shall be allowed to keep her child till it attains the age of six years. Thereafter, the child shall be handed over to suitable surrogate as per the wishes of the mother or shall be sent to suitable institution run by the Social Welfare Department. The children admitted outside the jail shall be allowed to meet their mother in the jail once a week.

- 19.10.3 The child shall be given proper education and recreation opportunities and shall be kept in crèche or nursery, which shall preferably be run outside the main prison premises.
- 19.10.4 Every child who is allowed to remain with his/her mother in the jail shall be provided the facility of crèche/nursery and visitation by relatives and NGOs.
