Whereas, the Superintendent Jails forwarded objections filed by the officials which were decided on merits by the Establishment Board in its meeting held on 17.02.2020.


Whereas, before finalizing the seniority list, a revised tentative seniority list after incorporating necessary changes based on the recommendation of Establishment Board was circulated vide Prisons Directorate circular issued under endorsement No. Esstt./216/ 2019/13145-59 dated 19.03.2020 for information of all concerned and filing of objections (if any) within week's time.

Whereas, Superintendent, District Jail Kupwara vide letter No. Esstt./82/DJK/2020/04 dated 09.04.2020 forwarded objection of Head Warder, Mohd. Ashraf Wani to the tentative seniority list.

Whereas, the official sent an application dated 05.01.2021 for withdrawal of his claim. The establishment board members met on 08.01.2021 to discuss the case and recommended that the final seniority of Head Warders be issued as it was circulated vide No. Esstt./216/ 2019/13145-59 dated 19.03.2020.

Now, therefore, in view of recommendation of Establishment Board members, the final seniority list of Head Warders is hereby issued as it stands on 1<sup>st</sup> January, 2021, for information of all concerned. The said seniority list is circulated among all the Superintendent Jails in terms of Rule 24 of J&K Classification, Control and Appeal Rules, 1956 and notified as per Annexure to this office order.






The date of birth/category of the officials recorded in the seniority list is subject to further verification from service records also with reference to original matriculation/ qualification certificates of the concerned.
