

2. Bids must be accompanied with cost of tender documents in the shape of demand draft in favour of Superintendent Sub Jail Reasi and earnest money/bid security in shape of CDR/FDR pledged to Superintendent Sub Jail Reasi.
3. The date and time of opening of bids shall be notified on website www.jktenders.gov.in.
4. The bidders have to submit their bids online in electronic format with digital signature. No bid will be accepted in physical form.
5. Bidders must ensure to upload scanned copy of all necessary documents with the bid. Besides original/photo copies of documents related to the bid be submitted physically by hand/registered/courier before the date specified in para-1.
6. Bidders must ensure to upload scanned copies of all necessary documents including earnest money and tender document fee in terms of soft copies with technical bid and submit the hard copies of all the uploaded documents duly attested under the hand and seal of the tenderer. No documents which has/have not been uploaded shall be entertained in the form of hard copy. However, in case any clarification, the bidders shall have to produce original documents in support of soft copies if need arises.
7. The earnest money in favour of unsuccessful/No-responsive bidders shall be released only after ensuring submission of tender documents fee in original, irrespective of hard copies, failure of submission of tender documents fee by bidder using the site shall entitle him for blacklisting.
8. The department will not be responsible for delay in online submission due to any reason.
