5. Earnest Money Deposit (EMD) :

- (i) The bidder has to submit Earnest Money of ₹6.0 lakh (Rupees Six Lakh only) in the form of CDR/FDR issued by a scheduled bank, drawn and pledged in favour of FA/CAO Prison department and payable at Jammu. The bidder has to upload the scanned copy of the CDR/FDR alongwith other documents during submission of bid within the above-mentioned date and time of bid submission.
- (ii) The lowest bidder will be required to deposit CDR/FDR towards EMD, in original, in the office of FA/CAO Prison department J&K within 7 days of opening of financial bid.
- (iii) The EMD(s) of unsuccessful bidder(s) shall be released by FA/CAO of Prison department J&K after placement of Supply Order to the successful bidder. The Earnest Money deposited by the successful bidder will be refunded after submission of Performance Guarantee or execution of rate contract, whichever is later.
- (iv) For an SSI unit, the EMD shall be as per prescribed Government norms.
- (v) Earnest Money of the bidder(s) will be forfeited in following cases:
 - (a) When the bidder withdraws his bid during the period of bid validity on account of any reason.
 - (b) On failure of the successful bidder in furnishing Performance Guarantee equivalent to 3% of the quoted cost of successful bidder in the form of CDR/FDR or in the shape of Bank Guarantee within 07 days from the date of opening of price bids.
 - (c) In case the successful bidder fails to execute the contract agreement within 07 days of issuance of supply order.

7. SUBMISSION OF BIDS: The bid to be uploaded by the bidder shall be in two separate parts.

B. Part II shall be named Price Bid:

Price bids of only those bidders would be opened (in online mode) who qualify in Technical Evaluation of bids and whose samples are approved by the department(wherever applicable).

8. Bid Validity :

The Bid would remain valid for a period of 120 days from date of opening of price bid. In exceptional circumstances, Prison department may request the successful bidder to extend the period of bid validity for a specified additional period. The request of the Prison department and the bidder's response shall be made in writing or by e-mail. A bidder agreeing to the request of the Prison department for extension of period of Bid validity will not be permitted to modify his Bid but will be required to extend the validity of his Bid for a period of the extension as sought by the department.

9. Performance Security

Successful bidder will have to furnish Performance Security equivalent @ 3% of the quoted cost of the successful bidder in shape of CDR/FDR/Bank Guarantee within 7 days of opening of price bid.

Performance Security of the successful bidder (equivalent to 3% of the quoted cost) shall be released only after successful completion of supplies to the satisfaction of the department and only after deducting outstanding amount, if any, from the supplier on account of any reason.

10. No price escalation:

The rates and price quoted by the bidder shall be deemed to include any price escalation upto completion of period of rate contract, (Financial year 2023-24) unless otherwise specified separately.

11. Validity of Rate Contract:

Department may extend the period of rate contract beyond the FY 2023-24 at rates mutually agreed by both the parties which will not be higher than the rate approved for FY 2023-24

12. Taxes:

The rates and price quoted by the bidder should be in Indian rupees only and the quoted rates shall be deemed to include all taxes, royalties, levies, toll, surcharge etc. upto completion of the supply orders unless otherwise separately and exclusively specified. Deduction of amount of applicable taxes from the bills of the supplier shall be as per prevailing rates at the time of effecting recovery.

13. Force Majure:

In circumstances beyond the control of the supplier, time extension for completion of the supply order may be given by the department at the discretion of the department keeping in view the time elapsed due to circumstances beyond the control of the supplier.



14. Advance payment/Mobilization advance

No mobilization advance or advance payment in any manner shall be made to the supplier unless otherwise specifically provided in the bid document or the supply order.

15. Penalty for delay in completion of supplies as per supplies:

- a. In case of delay in completion of the supply order beyond scheduled period of delivery, a penalty at the rate of 1% per week (on pro-rata basis) on the amount of unexecuted supplies shall be imposed on the supplier subject to a maximum of 10% of the contract value.
- b. Non-cooperation of the supplier or his representative with departmental officers and any act of misbehavior or disrespectful conduct by the supplier or his representative with departmental staff shall invite penalty as decided by the DG Prisons J&K which shall be binding on the supplier.
- c. If the successful bidder fails to supply the items of prescribed specifications or fails to deliver the goods within stipulated time as mentioned in the Supply Order, the department will be at liberty to arrange supplies from any other alternate source(s) and recover extra cost, if any, from the default supplier which may be effected through forfeiture of Performance Security also.

16. Arbitration:

No arbitration is allowed.

17. Dispute Resolution Mechanism:

If any dispute or difference of any kind, what-so-ever, arises between the department, its authorized representatives and the supplier, in connection with or arising out of the contract or the execution of supply order, it will be first attempted to be resolved amicably at the department level. However, if the dispute still remains unresolved, then matter would be referred to concerned Administrative Department, J&K for resolution, whose decision shall be binding on both the parties.

The Jurisdiction of the court(s) in any case shall be within Union Territory of J&K.

18. Documents comprising the bid:

Following documents which are not submitted with the bid shall be deemed to be part of the bid :



- (a) Notice Inviting Tender
- (b) Tender Document.

19. Integrity of the bid process:

Information relating to clarification, examination, evaluation, comparison of bids, recommendations for award of contract, approval thereof etc. during the bid process are all confidential. All bidders are advised not to make any attempt to influence any officer/official of the department or any person related to them. Any such attempt may result in disqualification of the bidder at any stage of the bid process including appropriate action under existing provisions of law.

20. Production of original documents on demand:

All bidders including the successful bidder will have to produce original documents before the department at any stage of the bid process or even during execution of the rate contract, on demand, for verification or for any other purpose.

20. Extension of time for Completion of supply order.

The department may extend the scheduled completion date of supplies if delay is on part of department or due to Force Majeure or a variation is issued or due to any other reason.

The department shall decide whether and by how much period the scheduled completion date is to be extended. If the supplier fails to give early warning of a delay or fails to cooperate in dealing with a delay, the delay by this failure shall not be considered in assessing the new completion date.

21. Sample of the Supplies

Samples of all items as per enclosed **Annexure "K"** should necessarily be deposited in the office of Director General of Prison, J&K before the last date and time of submission of bids and acknowledgment for depositing these samples should be obtained by the bidder from the concerned official in the office of DG Prisons. Samples deposited by the Tenderer(s) who are not declared successful Bidder(s) shall be lifted back by the concerned Tenderer within a period of 07 days from the opening of Price Bids. Department shall not be responsible for any damage/loss caused to the samples for which rates have not been approved. In case the same are not lifted by the Tenderer(s) within the aforementioned prescribed period, samples will be disposed off by the department and the department shall not be liable to pay any compensation/ damage to such bidders on account of disposal of samples.

Samples are necessary in respect of items indicated in Annexure "K" only.

22. Agreement

The successful Bidder shall have to execute Contract Agreement with Department within 07 days of allotment of Contract/issuance of Letter of Intent.



23.

Payment

Payment shall be made by the Department only after the consignment delivered by the Successful Bidder is properly inspected, surveyed, accepted and brought on stock of the department in the concerned Stock Register.

24.

Remission Charges

Remission charges/Bank Commission on account of payment made to the Successful Bidder shall be borne by the Supplier only.

25.

Inspection of Premises

The representative of the department shall have access to the Supplier's Premises and shall have the power at any reasonable times to inspect and examine the materials and workmanship, whenever found necessary.

26.

Supply order:

- a. If after finalization of the Rate Contract/Placement of SupplyOrder / execution of Contract Agreement, the successful Tenderer backs out or fails to supply goods, Performance Security and/ or EMD of the Tenderer shall be forfeited. Any loss sustained by the Govt. as a result of re-tendering for supply of goods shall be recovered from the Default Tenderer, besides any other remedy that may be available to the Department under law for the time being in force.
- b. Supply order shall be placed in favour of the Successful Tenderer by concerned, Jail Superintendent(s) indicating quantities of different material to be supplied (based on their optimum requirements, keeping in view the number of jail inmates) Period of delivery can however be extended by the authority placing the Supply Order in case of justified reasons at the discretion of the department.
