Assistant Superintendent Jail.**

Pursuant to the approval conveyed by the Home Department, J&K vide communication no. HOME-Jail/12/2022[131747] dated 10.02.2025 and recommendations from J&K Service Selection Board, Jammu/Srinagar vide Order No. 352-SSB of 2024 dated 17.10.2024, sanction was accorded to the temporary appointment of **Mr. Shahzada Musharib Kawsar S/o Mr. Mushtaq Ahmad Shah R/o Lazibal, Anantnag** as "Assistant Superintendent Jail" under "OM Category" in the **Pay Level-6C (35700-113100)** against the available vacancy in the Prison Department vide **Prison Headquarters, J&K Order No. 94-Prison of 2025 dated 21-02-2025**. He was ordered to be posted at **Central Jail Srinagar** vide the referred order.

Superintendent, Central Jail Srinagar vide communication no. Esstt/138-CJS/4247 dated 25.02.2025 informed that the appointee had joined at Central Jail Srinagar on 24.02.2025, FN.

Superintendent, Central Jail Srinagar vide communication no. Estt/138-CJS/4407 dated 06.03.2025 forwarded application of the appointee for withdrawal from selection/joining.

The appointee again, vide email from email ID (smushikawsar@gmail.com) dated 11.03.2025, received on official email of Prison Headquarters (prison@jkpolice.gov.in), submitted an application regarding his resignation from the post of Assistant Superintendent Jail.

Prison Headquarters, J&K vide communication no. Esstt/CC-7603653/11910 dated 20.03.2025 requested Superintendent, Central Jail Srinagar to furnish attendance report of the appointee.

Superintendent, Central Jail Srinagar vide communication no. Esstt/138-CJS/4587 dated 20.03.2025 informed that **Sh. Shahzada Musharib Kawsar, Probationary Assistant Superintendent Jail** had joined at **Central Jail Srinagar on 24.02.2025 F.N.**, thereafter he has not reported at **Central Jail Srinagar**.



The matter has been examined/considered with reference to the rules governing the subject. The concerned official is still on probation and has not qualified prescribed probation period of service.

Rule 21(1) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956 provides as under:-

**“At any time before the expiry of prescribed period of probation the appointing authority may”:**

- a. **suspend the probation of a probationer and discharge him from the service for want of vacancy; and**
- b. **at its discretion terminate the probation of a probationer and discharge him from the service.**

Therefore, in view of the above and in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by **Mr. Shahzada Musharib Kawsar S/o Mr. Mushtaq Ahmad Shah R/o Lazibal, Anantnag, Probationary Assistant Superintendent Jail, Prisons Department** is hereby accepted and his probation/services as Probationary Assistant Superintendent Jail are hereby terminated from Prisons (Subordinate) Services w.e.f., **25-02-2025**.
