
The appointee shall report to the **Superintendent, Central Jail Srinagar** within a period of **21 days** from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently by Superintendent, Central Jail Srinagar :

- i. **Academic Qualification Certificates.**
- ii. **Certificate for proof of Date of Birth.**
- iii. **Domicile Certificate.**
- iv. **Health Certificate from the concerned Chief Medical Officer of the District.**
- v. **No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.**
- vi. **All other relevant documents as are required under SRO-43 of 1994.**

**The appointment of the appointee shall further be subject to the following conditions:-**

- i. That he shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, any document produced by him is found fake/forged, the appointment shall be treated to have been cancelled ab-initio and legal action, as warranted under law, shall be initiated against him.
- ii. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of all documents is received from the concerned issuing authorities in his favour.
- iii. The appointee shall be initially on probation for a period of two years from the date of joining.
- iv. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- v. If the appointee fails to join within a period of **21 (twenty-one)** days from the date of issuance of this order, he shall forego his right to appointment, which shall be deemed to have been cancelled ab-initio, without any further notice.
