## TERMS AND CONDITIONS OF MEDICINES

- The rates tendered for should be quoted both in words and in figures F.O.R.
   District Jail Rajouri and should be inclusive of all taxes including GST, if any
- Tenders should quote clearly, no additions / alterations/ overwriting / mutilations etc should be made in tender. Correction if any done in tender should be clearly and properly authenticated by the tenderer.
- The quantities of different items/ medicines will depend on the actual requirement to be assessed from time to time or as per advice/prescription of MO jail, Doctors etc
- 4. The tender shall be accompanied with the earnest money in the shape of CDR/FDR pledged to Superintendent District Jail Rajouri for an amount mentioned in the original NIT.
- 5. Tenders without CDRs/FDRs shall not be entertained and shall straight way be rejected. No Cheques, Bank guarantee, Postal Orders / Vikas Patras / Demand drafts etc shall be entertained in place of CDR/FDR.
- 6. Payment shall be made by the department only when the consignment delivered is properly inspected, accepted, surveyed and brought on stock in the concerned Stock Register of the Jail. No advance payment shall be made.
- Remittance charges (Bank Commission) on payment made to the firm shall be borne by the Suppliers.
- 8. The approved supplier shall be deemed to have fully understood the conditions, specification, size, pattern, make etc. of the articles to be supplied and in the case of any doubt to the meaning of any of these portions / specifications etc. may get clarification before signing the contract.
- 9. As soon as the acceptance of the tender is communicated to the successful tenderer/bidder, the contract shall be binding on him. The earnest money of the tenderer who backs out or withdraws his tender or fails to abide by it after acceptance shall be forfeited besides other remedies that may be



- available to the Government of J&K under the law for the time being in force in the UT of J&K shall be applied
- 10. If after the finalization of the Rate Contract / placement of order / execution of the agreement, the tenderer backs out or fails to supply the medicines/goods, CDR will be forfeited and any loss sustained by the Government as a result of re-tendering of the contract shall be recovered from the defaulter besides any other remedy, that may be available to the Department under the law for the time being in force in the UT shall be applied.
- 11. The supply shall have to be made to the satisfaction of survey committee of jail or superintendent jail.
- 12. In case of any dispute, the decision of the Superintendent Jail/committee shall be final and binding upon both the parties. However in case the decision of Superintendent Jail is not acceptable to the tenderer/bidder, the legal proceeding could be initiated only in courts of J&K.
- 13. If the contractor fails to supply the items and time the department will arrange the same on the risk and responsibility of contraction. The extra cost if any shall be recovered from the contractors.
- 14. The tenderer/bidder who once submits tender shall not be allowed to withdraw it before finalization.
- 15. The medicines must be latest manufacturing batch with minimum expiry of 10 to 12 months from the date of receipts by medical unit of this Institution.
- 16. The tenderer must quote the discount percentage on MRP of the Items.
- 17. The rebate/discount offered will be taken into account after proper evaluation.
- 18. The tenderer/bidder for supply of medicines should be a registered dealer and has to submit the registration certificate.
- 19. The supplier has to supply the medicine to the Jail on his own. No official will be deputed from the Jail to collect the medicines from the approved tenderer / supplier.
- 20. The medicines supplied should be from registered /recognized and renowned companies keeping in view the manufacturing /expiring dates. Only ethical / genuine medicines should be supplied, no other generic medicines in any way will be accepted by this office.

- 21. Only those medicines/items be supplied and accepted which are required as per supply order of jail or as per prescription of Doctors/MO jail. Any substitute/ generic/ alternate medicine will not be entertained and no payment will be release for such alternate medicines. Only originally prescribed medicines by MO jail/ Doctors be supplied by tenderers/ suppliers and paid accordingly.
- 22. The tenderer should possess a valid drug license and should attach a photocopy with the tender documents.
- 23. The medicines have to be supplied on daily basis as per requirement and it has to be ensured that the required medicines are supplied with in one day from the date of issue of supply order/requisition from Medical Officer Jail. In case of delay on the supply, the procurement will be made by this office from the market and the extra cost involved will be recovered from supplier with panel interest of 10%.
- 24. The medicine has to be delivered in the Medical Section of the Office.
- 25. No conditional tender shall be accepted.
- 26. The successfully tenderer/bidder shall have to execute an agreement with this Institution soon after the allotment is made.
- 27. If after final decision of the rate contract / placement of order execution of agreement, the tenderer/bidder fails to supply the medicine, his CDR/FDR will be forfeited.
- 28. In case of any dispute occurred, the decision of undersigned / chairman purchase committee of District Jail Rajouri shall be final.
- 29.In case any tenderer if charges higher rates for any items more than MRP, legal action as warranted under rules shall be taken against him besides forfeiture of his CDR/FDR earnest money / security deposits / Bank guarantee
- 30. The rates accepted shall remain in force for one year from the execution of agreement or till next rate contract will be finalized.
- 31. Tenders without CDR's/FDR's shall not be entertained.
- 32. Chairman of the District Level Purchase Committee reserves the right to accept or reject any tender or part thereof without assigning any reasons.
- 33. The rates accepted shall remain in force for one Year from the date of entering into the agreement or till the finalization of the new Rate Contract whichever is earlier.

- 34. The approved tenderer should submit income tax return under rules
- 35. The Income tax / Service Tax wherever applicable shall be deducted at source.
- 36. The tenderer must be registered GST dealer having GST Number.
